Notice of Public Meeting - 2021 Budget

A Public Meeting to consider the adoption of the 2021 Budget has been scheduled for Monday, March 8, 2021 at 7:00 PM. The meeting will be a virtual webinar hosted through Zoom. Climate Action Plan

A presentation and report regarding the ResiLienT Loyalist Township - Climate Action Plan, was received; and the Climate Action Plan and its goals were approved. Several of the goals and actions presented in this plan will have future financial implications, however Staff will present Council with a cost-benefit analysis when recommending the implementation of an initiative.

Pandemic Financial Relief Considerations

Council received a report regarding Pandemic Financial Relief Considerations, and approved a motion granting a one month extension for the February tax instalment and for the utility bills due in February and March before adding any penalties or interest charges.

Status Update on Resumption of Ferry Fares

Council received a report providing a status update on the resumption of Ferry fares. The report outlined the plan for the resumption of Ferry fares in early March 2021. Staff are continuing to develop options for an electronic fare collection system including a public consultation period to determine impact on proposed changes.

Public Meeting - Zoning By-law Amendment

A public meeting was held to consider an amendment to the Comprehensive Zoning By-law. The proposed amendment applies to property located in Loyalist Country Club Estates Phase 8. The approved amendment which affects 45 units to increase the maximum lot coverage to 44% for a single storey detached dwelling house or a single storey-semi detached dwelling house plus an additional 5% for accessory buildings and structures.
