Investing in Canada Infrastructure Program Agreement - Rehabilitation of Layer Cake Hall

A by-law to authorize the Mayor and Chief Administrative Officer to execute a Transfer Payment Agreement between the Province of Ontario and The Corporation of Loyalist Township related to funding provided by the Province of Ontario to The Corporation of Loyalist Township for the rehabilitation of Layer Cake Hall, under the Investing in Canada Infrastructure Program was enacted and passed.

By Resolution, Council formally recognized September 30th as the National Day for Truth and Reconciliation (also known as Orange Shirt Day) in partnership with the Association of Municipalities Ontario.

Notice of Public Meeting - Official Plan Comprehensive Review Amendment

The Proposed Comprehensive Amendment Update to Loyalist Township's Official Plan, in accordance with Section 17(15) of the Planning Act, will be presented at the September 27th, 2021, Council meeting for public comment.

Public Meeting - Loyalist Country Club Estates Phase 8 - Zoning By-law Amendment

A public meeting was held to consider an amendment to the Comprehensive Zoning By-law. The amendment - applying to Phase 8 of the Loyalist Country Club Estates in Bath -to reduce the minimum lot area from 370m² to 350 m² was enacted and passed by Council.

Public Meeting - Procedure By-law

A public meeting was held to receive comments on proposed changes to the Loyalist Township Procedure By-law. Notice is hereby given that Council, at its regularly scheduled Council meeting on Monday, September 27, 2021, intends to adopt By-law 2021-057 being a by-law to amend Procedure By-law 2018-090.

Notice of Public Meeting - Proposed Development Charge Rates

Proposed Development Charge Rates and Policies will be presented at the September 27th, 2021, Council meeting for public comment.

Non-Standard Procurement Process - Grant Management Services

Council approved using a Non-Standard Procurement approach to obtain the services of GrantMatch, and authorized the Mayor and CAO to sign an agreement with GrantMatch to assist with the development and management of a proactive Government Funding application process for the Township.

2021 Miscellaneous Fees and Charges Amendments

Council received a report recommending changes to certain recreation fees and charges for 2021 and approved a bylaw to amend the current miscellaneous fees bylaw to reflect these changes.

Backyard Hen Draft By-law Update

Council received a report with an update on the draft Backyard Hen By-law. Included in the update was the date (October 12, 2021) that has been established for the public meeting along with a communication plan for engaging stakeholders.

Renewable Energy Vibrancy Policy Update and Amended Terms of Reference

Council approved the amended Terms of Reference for the Renewable Energy Vibrancy Policy and Council directed staff to plan a Virtual Public Information Session with notice being provided to all Loyalist households via direct mail.

Council Supported the Following Resolutions Circulated from other Municipalities

City of Hamilton - Request that the Province of Ontario promptly expediate the expiry of O.Reg 131/20, the COVID exemption for after-hours noise from construction sites.
