Public Meeting and Notices of Meeting

175 Hegadorn Road, Odessa – Zoning By-law Amendment D14-004-2022

A public meeting was held to receive any comments by any person who claims to be affected by the application. By-law 2023-047, being a by-law to amend the Rural (RU) Zone to Rural Exception Sixteen (RU-16) Zone to permit a secondary unit in a detached accessory building was enacted and passed.

Emma Street Road Closing

A public meeting was held in accordance with Township [By-law 2004-33](#) which proposes to stop up, close and sell part of the Township Road allowance as described as Part of Emma Street Plan 91; Part of Lots 211, 212; Plan 91 Part of Part 1 29R7060 and more particularly described as Part 1 on Reference Plan 29R-11074 Loyalist Township and sell Reserve Block 36 on Plan 29M57, Loyalist Township. By-law 2023-050 authorizing the close, stop up and sale was enacted and passed.

Delegations/ Presentations

Audra McMullen, a resident of Amherst Island, appeared before Council virtually with a presentation and video thanking Council and the Heritage Committee for their support in the restoration of approximately 80 feet of heritage wall, and to demonstrate the value on investment and successes of the project.

Parks and Recreation Master Plan

Council directed staff to hire a consultant for the completion of a new Parks and Recreation Master Plan and approved a budget of \$130,000 for the completion of the Parks and Recreation Master Plan including \$65,000 to be funded in 2023 through operational savings or if required to be funded from the General Tax Stabilization Reserve and \$65,000 to be pre-approved in the 2024 operating budget. Council resolution 2023.7.10 regarding sport courts in the Township be considered within the new Parks and Recreation Master Plan and as per the recent splash pad public engagement. Council recognizes the communities desire for a splash pad, therefore the new Parks and Recreation Master Plan is to identify the preferred location for a splash pad and that funding be included in the 2025

capital budget and given the generous offer of an anonymous donation for a skate park and pump track, that these amenities be considered and location identified in the new Parks and Recreation Master Plan.

Community Transportation Update

Council approved staff to issue a request for expression of interest to identify transportation service providers who have the resources to provide the service as generally described in the Loyalist Township Transportation Proposal approved by the County of Lennox and Addington.

Proposed Provincial Planning Statement

Council endorsed the comments on the proposed Provincial Planning Statement as outlined in Staff Report SR-2393, other than the comments related to Settlement Area Boundary Expansions, consents on Rural Lands and Sewage, Water and Stormwater on pages 5, 7 and 9; and Council directed staff to submit comments as outlined in Staff Report SR-2393 with the exception of comments related to settlement area boundary expansions, consents on rural lands and sewage, water and stormwater on pages 5, 7 and 9, as well as any additional comments Council may wish to include, to the Ministry of Municipal Affairs and Housing in response to the Environmental Registry of Ontario posting on the proposed Provincial Planning Statement prior to the August 4, 2023 commenting deadline.

Heritage Permit Application - 100 Bridge Street, Odessa - Booth - Babcock Mill Wheelhouse

The submitted Heritage Permit Application was approved to allow work to commence to secure the Wheelhouse of the Booth - Babcock Mill at 100 Bridge Street in Odessa with the condition that tapcon screws be covered or painted to match the colouring of the steel sheeting.

Millcreek Subdivision Phase 1 Stage 2 Block 32 and 36 - Part Lot Control Request

By-law 2023-051, being a by-law to lift part control requirements for Blocks 32 and 36 on Registered Plan 29M-57, for the Millcreek Phase 1 Stage 2 Plan of Subdivision was enacted and passed.
