Delegations and Presentations

A representative of the 1st Amherstview/Bath Scouts appeared before Council asking for consideration for the waiving/subsidizing of costs for the use of the Hall from September to end of June be supported.

The Lennox and Addington County Community and Development Services Director provided a presentation regarding Economic Development in both the County and Loyalist Township.

Strategic Plan Update and Proposed Workplan

Council received and approved the proposed workplan as contained in the report to update the Strategic Plan to 2027.

Establishment of a Reserve Fund for Family Physician Recruitment Incentive Program

Council approved the creation of a Family Physician Recruitment Incentive Program and authorized staff to submit an application to the Renewable Energy Fund grant program for \$60,000 in 2023.

Free Use of Facilities Requests

Council approved the following requests:

- 999 Air Cadets for the free use of WJ Henderson Arena between 4 pm and 9 pm on June 5 and 6, 2023; and
- 1st Amherstview/Bath Scout Group a subsidized hourly rate for the use of the Amherstview Community Hall 6:30 pm to 8:00 pm, Mondays, September 11, 2023 through June 24, 2024.

Amherstview Jets Junior C Club Request for Advertising Rights

Council authorized the Mayor and CAO to sign a two-year agreement, beginning in the 2023/2024 ice season, for a pilot project assigning advertising rights to the Amherstview Jets Jr. C Club including the

arena boards, arena ice, the Zamboni and sports field fencing for an annual fee of \$15,000; and that on completion of the pilot project, staff report back to Council regarding the outcome of the agreement and make recommendations on the future of advertising in Township facilities.

D14-003-2023 - Babcock Mills Phase 5 - Request to Remove Holding Symbol

Council enacted and passed By-Law 2023-030 being a by-law to remove the holding symbol with respect to Part of Lot 30, Concession 4.

Heritage Permit Application - Booth - Babcock Mill at 100 Bridge Street, Odessa

Council approved the submitted Heritage Permit Application to allow work to begin on the clean-up and first phase of restoration of the Booth-Babcock Mill, 100 Bridge Street, Odessa.
